The following Terms of Service, together with the Privacy Policy and all other policies referenced herein or other documents to which they refer to constitute the binding legal agreement (this "Agreement") between Naviworld Limited having its registered address at Arch. Makariou III, 227, Doma Building, 3105, Limassol, Cyprus. directly or via or it's other affiliates ("Naviaddress") (collectively, "us", "we," or "Naviaddress") and you governing all use of the [online] a system of addressing any place and any object with simple numbers (the "Platform") and other Naviaddress Solutions (as defined below) for use by any individual or entity, being a User that uses any aspect of the Naviaddress Solutions:

1) DEFINED TERMS

- a) "Application": the Naviaddress smartphone Application available for download on third party Application stores such as AppStore and Google Play.
- b) "Content": images, maps, photos, video, audio, documents, edits, variations, layers, messages, polls, queries, posts, comments, signals, votes, ratings, rankings, and any other text, content, information or data, including Metadata, created, derived from or accessible via use of the Naviaddress Solutions, or otherwise made available by and to Users, including any of the foregoing provided by a User or by us.
- c) "Naviaddress Address": combination of digits assigned by us at your request to identify certain location, place or object.
- d) "Naviaddress Solutions": the Platform, the Application, the Site and the Services.
- e) "Metadata": data and information associated with or related to Content, including numerical latitude or longitude or similar coordinates, imagery, data derived from within images (such as without limitation street signs, landmarks, building names, etc.), and data generated by the capture of images (such as without limitation geolocation, time and date, network and system information, etc.).
- f) "Services": Naviaddress Address, the services, features, Application programming interfaces (APIs), and functionality accessible via use of the Site and the Application, including functionality for the provision, modification, display, and management of Content.
- g) "Site": Naviaddress.com and any web pages that are a part of <https://naviaddress.com>
- h) "Terms": these Terms of Use, and the Naviaddress Privacy Policy available at <https://naviaddress.com/docs/terms> , as may be modified from time to time.
- i) "User": you and any other user of the Naviaddress Solutions.

2) GENERAL USE

- a) If you do not agree to these Terms, you cannot use the Naviaddress Solutions. We reserve the right at our discretion to propose modifications to these Terms periodically. We will notify you of such changes via an email sent to the email address we have on file for you or via other notification mechanisms. Your continued use of and access to the Naviaddress Solutions after notice of such modifications indicates your acceptance of and agreement to the modified



Terms. If you violate any of these Terms, your permission to use the Naviaddress Solutions automatically terminates, unless such violation is waived by us in writing in our sole discretion.

- b) You may use Naviaddress Solutions to identify any location, place or object and facilitated provision of services relating thereto.
- c) You may use the Platform and Service only for lawful purposes for your own needs within the stated context of Naviaddress' intended and acceptable use of the Platform. If you are downloading, accessing or using the Service on behalf of an entity, you represent and warrant that you are authorized to accept this Agreement on such entity's behalf, and that such entity agrees to take responsibility for use of the Platform and Service in compliance with this Agreement and indemnify Naviaddress for your violation of this Agreement. Naviaddress is the sole interpreter of the Platforms' intended and acceptable use that enables you to utilize the Platform.
- d) The profiles of Users contained in Naviaddress' search results are created by people over whom Naviaddress exercises no control. We cannot guarantee that Users are who they claim to be. We do not confirm the accuracy or completeness or any Content. Naviaddress assumes no responsibility, and disclaims all liability, for the content, accuracy, completeness, legality, reliability, or availability of such Contents or other data and/or information available on the Platform.
- e) Naviaddress reserves the right to suspend or terminate your access and use at any time if Naviaddress determines that you are in breach of this Agreement. Any termination shall take effect without prejudice to any damages that we might claim from you and your legal representatives, in compensation of the loss suffered as a result of any breach or otherwise provided under this Agreement. Your use of the Platform may be suspended or cancelled at any time, for any reason, on a temporary or permanent basis. You must immediately cease using the Platform should you receive a notice suspending or cancelling your license to use the Platform.
- f) You acknowledge that use of the Naviaddress Solutions requires connection to, and data transfers over, the network and therefore may impact your data usage charges imposed by your wireless operator or other service provider. It is your responsibility to obtain at your cost all equipment, software and internet access necessary to use the Naviaddress Solutions.
- g) Some of the Naviaddress Solutions may be available for additional fee, in which case additional agreement will be made by and between you and Naviaddress.

3) ACCOUNT

- a) You will need to register with Naviaddress and set up an account to access the Platform and Naviaddress Solutions and select your own sign-in ID and password to gain access to accounts. All accounts must have a valid associated mailbox for receiving electronic text mail.
- b) We also may refuse to grant you a user name that impersonates someone else, is protected by trademark or other proprietary right law, or is vulgar or otherwise offensive. We may also release user information in the event we believe that you are in violation of this Agreement, or that you have used the Service to commit unlawful acts, or if the information is subpoenaed or otherwise requested by the authorities and/or if we deem it necessary and/or appropriate.
- c) If you register, you agree to (a) provide true, accurate, current and complete information about yourself as prompted by our registration form (including your email address or social network profile) and (b) be responsible for the confidentiality and use of your username and password and not transfer or resell your use of or access to the Service to any third party. Naviaddress



is not responsible and disclaims all liability if your email is used improperly and falsely by a third party.

- d) You cannot transfer your Naviaddress account another user or entity. To protect your account, keep your account details and password confidential. You are responsible for all activity that occurs under your Naviaddress account.
- e) If your Services are cancelled or your Naviaddress account is closed (whether by you or us) your right to use the Services stops immediately and your licenses end and we will delete your Content associated with your Naviaddress account.
- f) We may require you, as a condition of membership, to change your username if we believe inappropriate (such as when a trademark owner complains about a username that does not closely relate to a user's actual name).
- g) Account Termination. We may terminate your or any other User's account for cause, including without limitation for: (a) violation of these Terms; (b) abuse of Naviaddress resources or any attempt to gain unauthorized entry to the Naviaddress Solutions; (c) use of the Site or any Service in a manner inconsistent with the purpose of the Services; (d) such User's request for such termination; or (e) requirements of or for failure to comply with Applicable law, regulation, court or governing agency order, or ethical requirements. We may in addition terminate the availability of the Naviaddress Solutions for our own business reasons, including if we elect to cease being in the business of providing it. Our termination of any User's access to the Solutions may be without notice and, on such termination, we may immediately deactivate or delete any User's account and Content, and/or bar any further access to the Site and Services. 4) ACCESS AND LICENSED RIGHTS

- a) Naviaddress Solutions Access. Subject to your compliance with these Terms, we hereby grant to you, solely for your own use: (a) access to the Naviaddress Solutions and (b) rights to Content displayed by us under license terms that we specify from time-to-time. Access and rights to the Application are as set forth in these Terms. Breach of such license terms will result in automatic termination of your access to the Naviaddress Solutions and Content, unless waived by us in writing in our sole discretion.
- b) All (i) text on every page of the Platform, whether editorial, navigational, or instructional; (ii) logos, buttons, and other graphical elements on the Platforms; (iii) software including both client-side code and server-side code used by Naviaddress to provide Naviaddress Solutions; iv) color combinations, button shapes, page layout, design and all other graphical elements of the Platform, materials, methodologies, implementation plans or other intellectual property used during the provision of Services ("Naviaddress Content"), the Platform and all right, title and interest therein are the sole property of Naviaddress or its licensors. Naviaddress Content are protected by copyrights, patents, trade secrets or other proprietary rights, some of them are also protected as registered or unregistered trademarks, trade names, and/or service marks owned by Naviaddress.
- c) Except for the limited licenses expressly granted to you in this Agreement, Naviaddress reserves for itself and its licensors all other rights, title and interest. By using our Services, you do not acquire any ownership rights in Naviaddress Content or materials contained therein. All Naviaddress Content remains our intellectual property, including (without limitation) any source code, product recipes, usage data, ideas, enhancements, feature requests, suggestions.



- d) Naviaddress User Licenses to Us. You and each User hereby grant to us the perpetual, irrevocable, worldwide, royalty-free, fully paid-up, sub-licensable, non-exclusive right and license to use, reproduce, modify, create derivative works of, perform, display and distribute without restriction (including via any medium) Content, in whole or in part, for commercial and non-commercial purposes, including (a) for purposes of providing, developing, improving, making available (including via public search engines), promoting and marketing the Naviaddress Solutions and (b) making available User Content. Further, you agree that we are free to use and implement in perpetuity without compensation, attribution or obligation to you any feedback, benchmarks, requirements, suggestions, criticisms, improvements, recommendations, ideas, and error corrections provided by you to us relating to the Naviaddress Solutions.
- e) You acknowledge and agree that we may continue to store, display and otherwise exercise the rights set forth in section 1.3 above with respect to your Content even after termination, deactivation, deletion, or archiving of your account.
- f) Reservation of Rights. No other right or license to the Naviaddress Solutions or Content is provided, and no other license will be implied, by course of conduct or otherwise. We grant no right or license with respect to our patents.

5) CONTENT

- a) User Content. The Application temporarily stores your Content in a manner such that deletion or malfunction of the Application or malfunction of the device on which the Application is installed may result in the permanent deletion of your Content. Content is not uploaded and stored on our servers until the Content is uploaded via the upload mechanism in the Application. Once your Content is uploaded, all Content locally stored on your device is deleted permanently. We may at any time filter, alter, modify, crop, or delete such Content in whole or in part before making it available on the Site and via the Service in our sole discretion, including in order to render the Content suitable for use on the Naviaddress Solutions. We are under no obligation to publicly display Content that is posted to private repositories, or that is hidden by election of the contributing User. You hereby waive any moral, neighboring or other rights you may have (including rights in the nature of attribution, integrity, privacy, paternity, and rights to object to derogatory treatment) in your Content that would otherwise preclude us from filtering, altering, deleting, or using, copying or distributing, in accordance with these Terms, your Content.
- b) Propriety of Content. All Content is the sole responsibility of the User from which such Content originated. No User will transmit Content or otherwise conduct or participate in any activities on or via the Naviaddress Solutions which, in our sole judgment, is likely to be prohibited by law, or is violative or in breach of third party rights in any Application jurisdiction, including without limitation laws governing libel and defamation, encryption of software, the export of technology, the transmission of obscenity or the permissible uses of intellectual property. You represent and warrant that all Content you submit is accurate and not misleading to the best of your knowledge, is not confidential or privileged, and is not in violation of third party rights. We may, in our sole discretion, terminate the Services as to any Content that we believe in our sole judgment is not in compliance with these Terms. We may preserve and disclose Content if required to do so by law or judicial or governmental mandate or as reasonably determined useful by us to protect the rights, property or safety of Users and/or the public.
- c) Prohibited Content. User Content or information that is unlawful, fraudulent, discriminatory, threatening, abusive, libelous, defamatory, obscene or otherwise objectionable or that contains sexual, ethnic or racial or other discriminating slurs, or material which contains no



relevant or constructive content, which goes beyond profanity into obscenity or abhorrence, or which is otherwise in violation of the law. Users are also prohibited from posting any User Content that contains proprietary information, trade secrets or confidential information. User Content may not contain any advertisements, solicitations, chain letters, pyramid schemes, investment opportunities, or other unsolicited commercial communication (except as otherwise expressly permitted by us), or encourage or cause spamming or flooding.

- d) **Use of Content.** Each User, by using the Naviaddress Solutions, may be exposed to Content that is offensive, indecent, objectionable, illegal, infringing, false or erroneous. Each User must evaluate, and will bear all risks associated with, the use of any Content, including any reliance on the quality, integrity, accuracy, completeness, or usefulness of such Content. We may refuse or delete any Content, including Content of which we become aware that fails to fulfill the purpose of the Services, is in breach of these Terms, is otherwise contrary to law, or is otherwise inappropriate in our discretion. We do not guarantee the accuracy, integrity or quality of any Content. Under no circumstances will we be liable in any way for any Content, including, but not limited to, liability for any errors, inaccuracies, or omissions in any Content, or for any loss or damage of any kind incurred as a result of the use of any Content. We will have no obligation or liability to you or any User to maintain, store, or license Content, protect and maintain Content owners' intellectual property rights, or to enforce these Terms. You hereby waive and release any claims you may have against us arising or resulting from use or misuse of Content or your inability to effectively use Content, your failure to comply with these Terms, or for any act, omission, or conduct of any Naviaddress User. If you as a user of the Naviaddress Solutions, sees Content that you consider inappropriate in any way, please inform us and identify how the Content in question fails to comply with these Terms by sending an e-mail to security@naviaddress.com and we will look in to the issue and delete any Content found in our discretion to be in conflict with these Terms.
- e) **Third Party Sites.** The Solutions, Users, or a third party may provide links to other websites or login access via such links. Such links will not be construed as an endorsement, sponsorship, or affiliation by us. We exercise no control over such other websites and web-based resources and are not responsible or liable for the availability thereof or the content, advertising, products or other materials thereon. We will not be responsible or liable, directly or indirectly, for any damage or loss incurred or suffered by any user in connection such other sites and resources.

6) SITE INTEGRITY

- a) **Prohibited Uses.** You will not use the Naviaddress Solutions in any manner that could damage, disable, overburden, or impair any Naviaddress-controlled server, or the network(s) connected to any such server, or interfere with any other party's use and enjoyment of the Naviaddress Solutions, including without limitation falsifying or altering Content posted by others except via normal and intended operation of the Services. You may not attempt to gain unauthorized access to other accounts, computer systems or networks connected to any of our servers or to any of the Services, including through hacking, password mining or any other means, or exploit bugs or vulnerabilities in the Naviaddress Solutions. - e) Notifications to You. You also agree that we may communicate with you in relation to your account and otherwise in relation to these Terms through your account or through other contact information you have provided to us, including email, mobile number, telephone, or delivery services including the postal service. You acknowledge and agree that we will have no liability associated with or arising from your failure to maintain accurate contact or other information, including, but not limited to, your failure to receive critical information about the Services. You agree that all agreements, notices, disclosures and other communications that we provide to you electronically satisfy any legal requirement that such communications be in writing.
- f) Network Security Risks. Because no online system is perfectly secure or reliable, the internet is an inherently insecure medium, and the reliability of hosting services, internet intermediaries, your internet service provider, and other service providers cannot be assured, you accept
